Revised Label

Purpose

The purpose of your submission is to submit revised labeling for our review for the

basic product and a distributor product.

Basic label

The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling to us, before you ship your product. A copy of the stamped label is enclosed for your records.

Existing stocks

Stocks of existing labels may be used for eighteen (18) months.

Distributor label

Normally, we do not review distributor labels. However, because we will never see a final printed label from the basic registrant and because this distributor label contains many obvious label violations, we have decided to review it.

Make the following changes to the distributor label which must be identical to the basic product label is all respects except for product name, company name and address, and registration number:

1. On the Front Panel, the graphic of the dog and cat running away in fear must be toned down. We have no data to support such a violent reaction to this product.

- 2. Chose a different color combination than black on green which violates the requirement for clear, readable text.
- 3. Insure that your label meets the minimum type size requirements for final printed labels, especially the ingredient statement. See the enclosure on this topic.
- 4. On the Back Panel, follow the formatting suggestions on the basic product.

Since this product is marketed in a 16 oz can, you will not have a problem in fitting in all the text in a easily read format. If you try to market this distributor product under this version, it could be cited for several labeling violations.
