**Shake Well Before Using**

**Use Restrictions**

Do not use in commercial food processing or preparation areas. In the home, cover all exposed food, food processing surfaces and utensils during treatment. Do not spray food or feed crops. Do not allow persons or pets to enter the treated area until sprays have dried. Do not apply this product in a way that will contact any person or pet, either directly or through drift. Keep people and pets out of the area during application.

**User Safety Requirements**

Follow manufacturers' instructions for cleaning/maintaining personal protective equipment. If no such instructions for washables exist, use detergent and hot water. Keep and wash personal protective equipment separately from other laundry.

**User Safety Recommendations**

Users should: 1) Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet; 2) Immediately remove clothing if pesticide gets on or inside clothing, then thoroughly wash with detergent and hot water and put on clean clothing; 3) Immediately remove personal protective equipment after handling this product. Use outdoors to prevent dogs and cats from disturbing flowerbeds, lawn areas, trees, shrubbery, fences, patio furniture and garbage cans/bags.

**Note:** This product is not likely to break the established urination patterns of dogs unless it is used as a training aid.

**Pretreatment Directions:** Stray animals are frequently attracted to areas that pets have soiled with feces or urine. To discourage repeat visits, remove any droppings and clean area with water.

**Application Directions:** Do not apply directly to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply to food or feed crops. Lightly spray surrounding soil or apply to a piece of cloth and affix near area to be protected.
