SHAKE WELL BEFORE USING - HOLD CONTAINER UPRIGHT

TO KILL FLEAS & LARVAE

CAGES: Hold sprayer at least two feet away from cage. Spray directly into cage. Also spray adjacent areas. DO NOT SPRAY ON PLASTIC CAGES.

PETS: Remove pet from cage. Hold sprayer and point nozzle opening in desired direction of spray. Spray the pet from a distance of 6-8 inches. Start spraying at the tail, moving the dispenser rapidly and making sure that the pet's entire body is covered, including the legs and under body. Fluff the hair so that spray will penetrate to the skin. Make sure spray wets thoroughly. Do not spray into eyes or face. Allow pet to dry before returning it to cage. As pet dries, keep it in a warm area to prevent it from getting chills. Repeat as necessary.

Pets and cages should be sprayed two to three times a week. It is advisable to replace bedding after each spraying.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area.

DISPOSAL: Do not re-use container. Wrap and discard in trash.
