DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Storage and Disposal

Storage: Store in a cool, dry (preferably locked) place inaccessible to children and pets. **Disposal:** Do not reuse empty container; wrap and put in trash.

Thoroughly soak animal with warm water taking 2-3 minutes to wet hair. Do not apply shampoo around eyes. Apply shampoo on head and ears, then lather; repeat procedure with neck, chest, middle and hind quarters, finishing legs last. Let animal stand 10 minutes (this is an important part of the grooming procedure), then thoroughly rinse animal. In extremely dirty or scaly animals, the above procedure may be immediately repeated, otherwise do not reapply product for 4 to 7 days. Do not use on puppies and kittens under 12 weeks. Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals. Pet bedding and quarters should be simultaneously treated with a product approved for such use.

Hazards to Humans and Domestic Animals

WARNING: Humans: Causes eye and skin irritation. Do not get in eyes or on skin or clothing. Harmful if swallowed. Thoroughly wash with soap and water after use. Remove contaminated clothing and wash before reuse. **Animals:** Sensitivities may occur after using ANY pesticide product for pets. First Aid

If on Skin or Clothing	<ul style="list-style-type: none"> • Take off contaminated clothing. • Rinse skin immediately with plenty of water for 15-20 minutes. • Call a poison control center or doctor for treatment advice.
If Swallowed	<ul style="list-style-type: none"> • Immediately call a poison control center or doctor for treatment advice. • Have person sip a glass of water if able to swallow. • Do not induce vomiting unless told to do so by the poison control center or doctor. • Do not give anything by mouth to an unconscious person.
