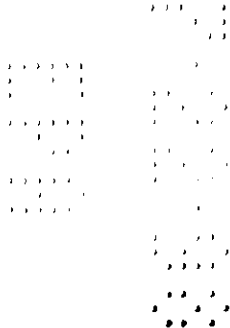

Cats and Dogs

Cover animal's eyes with hand and with a firm stroke to get a proper spray mist, spray head, ears and chest until damp. With fingertips rub into face around mouth, nose and eyes. Then spray neck, middle and hind quarters, finishing legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On long haired dogs rub your hand against the lay of the hair, spraying the ruffled hair directly behind the hand. Make sure spray thoroughly wets ticks. Do not repeat treatment for one week. Do not use on puppies or kittens under 12 weeks. Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals.

Pet's Sleeping Quarters

Spray around baseboards, windows, door frames, wall cracks and local area of floors. If mosquitoes, gnats or flies are present, spray lightly into the air. Repeat as needed. The pet's bedding should be sprayed, making sure the area beneath the bedding is sprayed too. After spray has dried, remove old bedding and replace with fresh bedding. Treat pets with a registered flea and tick control product before allowing them to enter treated area.

Horses

To control stable flies, horse flies and face flies, apply to face, legs, flanks, top line and other body areas commonly attacked by these flies. Repeat treatment as needed.

Storage and Disposal

Storage: Do not use or store near heat or open flame. **Disposal:** Do not use empty container. Wrap and put in trash.
