**DIRECTIONS FOR USE**

**Storage and Disposal**

**Storage:** Store in a cool, dry (preferably locked) place inaccessible to children and pets and away from heat or open flame.  
**Disposal:** Do not reuse empty container; wrap and put in trash.

**To Kill Fleas, Ticks and Lice:** Bathe pet with a quality cleaning shampoo. Dilute 1½ ounces (3 tablespoons) of dip concentrate in 1 gallon of water. Dip animal into solution, making sure hair is wet to the skin. Thoroughly sponge the area around the ears. Do not rinse off. Do not reapply for one week. Do not use on puppies or kittens under 12 weeks. Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals.

**Hazards to Humans & Domestic Animals**

**CAUTION:** Harmful if swallowed. Avoid contact with skin and eyes. Thoroughly wash with soap and water after use. **First Aid**
