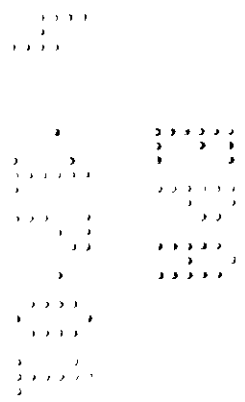

1. SHAKE WELL BEFORE USING.
2. Squeeze onto damp cloth or sponge and apply to soiled surface (or apply directly onto surface to be cleaned).
3. Remove loosened soil with dampened cloth or sponge.
4. Rinse with clean water. Leaves no slippery film.

To Kill Mildew on Hard Surfaces: Apply product to affected area. Let stand 10 minutes. Rinse off. Repeat when necessary.

To Disinfect Toilet Bowls: Flush first. Apply 4 ounces of material above waterline, under and around rim of bowl. Let soak 10 minutes. Swab all surfaces thoroughly. Then flush.

Avoid soaking on porcelain surfaces for more than 30 minutes.

Hazards to Humans and Domestic Animals

CAUTION. Irritating to the eyes and skin. Harmful if swallowed.

FIRST AID

IF IN EYES:

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- Call a poison control center or doctor for treatment advice.

IF ON SKIN OR CLOTHING:

- Take off contaminated clothing.
