STATEMENT OF PRACTICAL TREATMENT

alfalfa, artichokes, asparagus, winter barley, bermudagrass pasture, birdsfoot trefoil, corn, cotton, grass seed crops, oats, peppermint, red clover, sorghum, sugarcane, winter wheat, apples, bananas and plantains, blueberries, canberries, citrus, gooseberries, grapes, macadamia nuts, olives, papayas, peaches, pears, pecans, pineapples, walnuts.

Terrestrial non-food/feed uses:

ornamental bulbs crops, plumosus fern, established tree plantings (elm, caragana, cottonwood, Douglas fir, ash, honeysuckle, pine, cedar, Russian olive); fallow land; utility, highway, pipeline and railroad right-of-ways, petroleum tank farms, lumberyards, storage areas, industrial plant sites and around farm buildings.

Aquatic non-food/feed uses:

irrigation and drainage ditches.
