Dear Mr. Richter:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two copies of the final printed labeling must be submitted prior to releasing the product for shipment. A stamped copy is enclosed for your records.

Under MIXING DIRECTIONS AND INSTRUCTIONS section, delete the second sentence since the "literature" was not submitted for review. Add the following statements from the primary Eco San 1000 label: "Fill the spray tank 1/2 full of water and with the agitator running, add the required amount of Strawberry Best. Add water to fill the spray tank 3/4 full and when a spreader sticker cleared for application to strawberries is recommended, add the recommended amounts. Fill the spray tank and keep agitator running until spraying is completed."
