DANGER - PELIGRO

Mergal® S89 Paste is an antimicrobial preservative for control of fungi and algae growing on paints, coatings, plasters, sealants, and fillers used for architectural products, finishes, and special purpose coatings which are exposed to warm, moist, and humid conditions favoring microbial growth.

Typically Mergal® S89 Paste should be added at the final stage of the formulation process with mixing of the final product (paint, plaster, etc.) continuing to assure uniform distribution of the Mergal® S89 Paste.

PAINTS AND COATING MATERIALS (1.0 - 2.0%): Add 10 - 20 lbs. of Mergal® S89 Paste (4.5 - 9.0 kg) to each 1000 lbs. (453 kg) of paint. Use higher rate in warm, moist, and humid conditions where microbial growth is favored.

Plasters (0.1 - 0.3%): Add 1 - 3 lbs. of Mergal® S89 Paste (0.45 - 1.36 kg) to each 1000 lbs. (453 kg) of plasters. Use higher rate in warm, moist, and humid conditions where microbial growth is favored.
