On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit acceptable acute dermal toxicity, primary dermal irritation, and dermal sensitization studies performed with the subject product within eight (8) months of the date of this Notice. We note that a dermal sensitization study performed with technical fluridone was previously submitted and is currently pending with the Agency. This study will be reviewed to determine its acceptability to fill that data gap for this product. You will be notified upon the completion of the review.

2. Make the following label changes before you release the product for shipment:

a. Revise the EPA Registration Number to read, "EPA Reg. No. 67690-6".

b. According to previously submitted acute toxicity studies performed with technical fluridone, this product belongs in Toxicity Category II for eye irritation. Therefore, the following revisions are required in the precautionary language:

i. The appropriate signal word is "WARNING".

ii. Revise the Precautionary Statements to read as follows:

"Causes substantial but temporary eye injury. Harmful if swallowed, absorbed through skin or inhaled. Do not get in eyes, on skin or on clothing. Avoid breathing dust. Wear goggles, face shield or safety glasses when handling. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."

iii. Delete the phrase "...if irritation persists" from the end of the "IF IN EYES" statement.

iv. The "IF SWALLOWED" statement should read as follows:

"If Swallowed: Drink promptly a large quantity of milk, egg whites, gelatin solution, or, if these are not available, drink large quantities of water. Avoid alcohol."

c. Rewrite the Environmental Hazards section to read as follows:

"Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA."

3. Submit one copy of the revised final printed label for the record before you release this product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.
