The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Copper Compounds Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

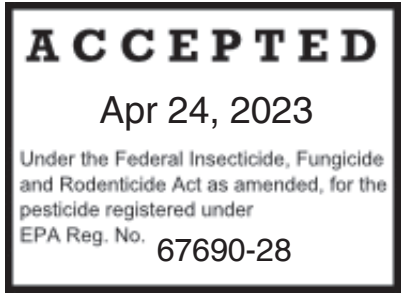

PRODUCT INFORMATION

SpinOut Spray is a root growth regulator that acts as a root pruning agent to control root spiraling and promote the development of a fibrous root system. Treated plastic, clay, wood, concrete or cellulose plant containers can be used to control root growth on container-grown trees, shrubs, bedding plants and houseplants at any stage of plant development from seedlings to large container-grown trees.

SpinOut Spray can also be sprayed over wounds and cuts in tree bark to seal the wound and help prevent bacterial and fungus infections of the tree. Spray an even coat of SpinOut Spray over tree wounds or cuts. One coat of SpinOut Spray should protect wounds or cuts for up to one year or until average size wounds have healed.

Use Restrictions

- **DO NOT** apply in a way that will contact adults, children, or pets, either directly or through drift.
- Use/apply only in areas with adequate ventilation.
- **DO NOT** apply directly on plants or soil except as a tree wound dressing.
- **DO NOT** apply when the temperature is below 50°F (10°C).
- **DO NOT** allow adults, children or pets to enter the treated area until sprays have dried.

Use Precautions

- Some containers, particularly bedding plant containers, may be treated with a slipping agent for easy unstacking. Slipping agents usually appear waxy and can prevent the

adhesion of SpinOut Spray. SpinOut Spray applications are not recommended under these conditions.

- SpinOut Spray may be reactive on metal surfaces. Avoid contact with metal surfaces.

APPLICATION DIRECTIONS

Plant Containers and Tree Wound Dressing

Plant containers/tree wound areas should be clean and dry before applying SpinOut Spray. Used containers should be free of any loose soil.

1. Protect surrounding areas with drop cloth or newspapers.
2. For best results, the aerosol can temperature should be between 70°F (21°C) and 90°F (10°C).
3. Shake the aerosol can vigorously for at least one minute after mixing balls begin to rattle.
4. Aim the opening of spray button toward the application site surface and away from you, taking care that fingertips do not extend over the front of the spray button.
5. While holding the aerosol can about 6 to 8 inches from the application site surface, press spray button firmly and move the aerosol can back and forth in a steady even motion. Do not try to achieve full coverage in one coat. Following the first coat, apply a minimum of two (2) additional coats for a better finish and longer root control/bacterial and fungus infection protection.
6. If clogging develops, carefully remove spray button from the aerosol can with a twisting motion and clean the opening. **DO NOT STICK PINS OR OTHER OBJECTS INTO CAN.** While holding the aerosol can and spray button opening away from you, replace spray button with a twisting motion.
7. Clean the spray button immediately after use by turning can upside down and pressing the spray button until no more product comes out.
8. Allow SpinOut Spray to dry thoroughly before filling plant container with soil.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal

Pesticide Storage: Store in a cool, dry place.
