

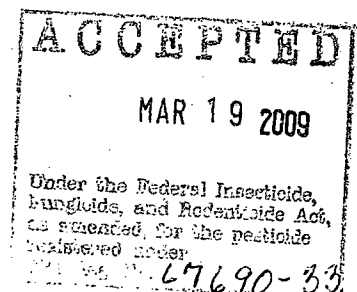

SpinOut Nursery Containers are pre-treated with a root growth regulator to control root spiraling and promote the development of a fibrous root system in container-grown woody ornamental and herbaceous plants and non-bearing fruit and nut crops. For the control of spiraling and promotion of a fibrous root system, transplant desired plant and root media to a SpinOut Nursery Container. Maintain normal growing practices for plant health and development. SpinOut Nursery Containers can be used at any stage in plant development from seedling to large container-grown trees or shrubs.
