Please find enclosed W. Neudorff GmbH KG's ("Neudorff's") application under PR Notice 98-10 for a notification concerning its registration for Sulfur/Pyrethrins Fungicide/insecticide RTU, EPA Reg. No. 67702-15. In essence, this notification would revise the product's label, as follows:

- (1) Eliminates one duplicative statement, i.e., "Shake well before using" from the Use Precautions section. This statement appears in the directions for use;
- (2) Eliminates two duplicative statements, i.e., "Do not dilute" and "Do not wet plants to point of runoff or drip" from the Use Restrictions section. The first statement is appears in the directions for use, while the second statement is duplicated in the Use Restrictions section; and
- (3) Makes two headings optional
