

To treat indoors, spray thoroughly into infested areas and insect hiding places, such as cracks and crevices, around baseboards and window and doorframes, underneath and behind, refrigerators, stoves, cabinets and garbage cans, under sinks, around plumbing, and in dark corners. Product can also be sprayed directly onto pests. Use stream setting for cracks and crevices. Repeat treatment as necessary.

Use outdoors on window and door frames, building foundations, under wood siding and any cracks and crevices around building foundation or stucco where pests may find entry and wherever pests are observed.
