- b. On the front panel beneath the product name, add "For Outdoor Use Around Residential Sites".
- c. Qualify greenhouses with non-commercial i.e., to read "Greenhouses (non-commercial".
- d. Since this product is for use around residential sites, under Environmental Hazards, delete "... to areas where surface water is present or to intertidal areas below the mean high water mark".
- e. Under Pests Controlled, clarify the types of ants to be controlled. Additional data are required if fire ants, harvester ants, Pharaoh's ants or carpenter ants are added to the label. If you do not wish to add these public health/structural pests, you must include a statement excluding these pests. Thus revising the statement to read "Pests Controlled: earwig, cutworms, sowbugs, pillbugs, crickets, ants (excluding fire ants, harvester ants, Pharaoh's ants and carpenter ants).
- f. Under application directions, add "Do not use food utensils such as tablespoons, cups, etc. for food purposes after pesticide use".
- g. Revise the first sentence under application directions to read "Scatter the bait granules on the soil around or near the plants with a suitable hand or power operated spreader (gravity or rotary) to ensure uniform coverage over the treatment area".
- h. If you are going to recommend the use of broadcast or granular spreader, then you must provide the users with suggested spreader settings so that they apply the correct amount of product to the area.
- i. The label claims and uses for this product must be consistent with the most restrictive of those of the two me-too products EPA Reg. Nos. 62719-282 and 67702-3. (1) Under Application Directions, revise the statement "Reapply as the bait is consumed or at least every four weeks" to read "Do not apply more than 3 times in any 30 day period." (2) In the list of alternate claims on page 3 5, revise the statement "Can be/may be used up to and including day of harvest" to read "Do not apply within 3 days of harvest".
- j. Under use sites, delete "(but not limited to)".
- k. Delete "For organic gardening and For Organic production". This is presently not acceptable for this specific formulation.
- 1. The word "Unique" may be used on labels produced for a period of six months following the date of registration.
- m. Delete "3 in I and Triple Actions", or explain what these pertain mean.
- n. Delete "Remains effective after rain or sprinkling, Rainfast, Rainfast pellets and Rainfast pellet formulation/formula". These statements contradict the statement "Reapply after heavy rain or watering".
- o. Delete "Can be used around domestic animals/pets and wildlife". Claims pertaining to the safety of a pesticide are not acceptable.
- p. Delete the safety/comparable claims "Does not contain metaldehyde, does not contain carbaryl, replacement for metaldehyde/carbaryl baits".
- q. Delete "Citrus groves" on page 6. This is a residential use product.
- r. Qualify artichokes as globe only i.e., to read "artichokes (globe)".
- s. Delete blackberries, boysenberries, raspberries. These crops do not have tolerances for spinosad.
- t. Add the registrant's telephone number beneath the company's name.

- 3. Submit to the Agency, data on one year storage stability testing (830.6317), conducted concurrently with the corrosion characteristics study (830-6320) at 0, 3, 6, 9 and 12 months of warehouse storage.
- 4. Submit two (2) copies of the final printed label bearing the above stated revisions prior to releasing this product for sale.

If you fail to comply with the above stated conditions, this registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

PESTS CONTROLLED: earwigs, cutworms, sowbugs, pilibugs, crickets, ants, slugs, snails

APPLICATION DIRECTIONS:

Scatter the bait granules on the soil around or near the plants to be protected. For broadcast application, use standard broadcast spreaders. For row application, use standard granular spreaders. Apply bait evenly at approximately 0.5 to 1 lb per 1000 square feet, or for smaller areas, 0.075 to 0.15 oz, or 0.5 to 1 teaspoon, per square yard. Do not place in piles. For slugs and snalls also scatter the bait around the perimeter of the area to provide a protective "barrier" for slugs and snalls entering the area. If the ground is dry, wet it before applying bait. The product works best when soil is moist but with little or no standing water.

Reapply as the bait is consumed or at least every four weeks. Apply at the higher rate if the infestation is severe. Re-apply after heavy rain or watering.

For seedlings spread the bait around the base of the stem. For trees or shrubs, spread the bait around the base of the tree. For small plots, treat around the base of the plants to be protected. In greenhouses, scatter the bait in the pots of plants being damaged or around pots on greenhouse benches.
