- 1. Revise the First Aid section to allow supplemental distributors to insert their own, toll-free, hotline numbers;
- 2. Revise the Hazards to Humans and Domestic Animals section to insert the word "using" before the word "tobacco:
- 3. In the Directions for Use, add an optional table presenting the existing directions for use in tabular form;
- 4. In the Directions for Use, add an optional sprayer instruction section
- 5. Add eight (8) optional marketing claims;
- 6. Revise one (1) existing marketing claim; and
- 7. Add two optional warranty statements.

Two (2) copies of the revised label are enclosed. One (1) of the copies has the revisions being made by this notification highlighted in yellow.

This notification is consistent with PR Notice 98-10 and EPA's regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. 




