PRECAUTIONARY STATEMENTS

Hazards To Humans And Domestic Animals

CAUTION

May be harmful if swallowed. Do not take internally. Avoid contact with eyes, skin and clothing. Avoid breathing vapors, dust, or spray mist. Wash thoroughly after handling. NOTE TO PHYSICIAN: Malathion is a moderate, reversible, cholinesterase in-hibitor. Atropine is antidotal.

ENVIRONMENTAL HAZARDS

OUTDOOR USE ON NONAQUATIC SITES: This pesticide is toxic to fish, aquatic invertebrates, and aquatic life stages of amphibians. Do not apply directly to water or wetlands (i.e., swamps, bogs, marshes, and potholes). Drift and runoff may be hazardous to aquatic organisms in areas near the application site. Do not contaminate water when disposing of equipment washwaters. This product is highly toxic to bees exposed to direct treatment on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area. INDOOR USE: Use only with adequate ventilation. After using this product indoors, ventilate thoroughly before occupying enclosed spaces. Do not allow contact with treated surface until sprays have dried.

DIRECTIONS FOR USE

Do not apply this product through any type of irrigation system. Use contrary to these directions may result in excessive Malathion residues, in unsatisfactory control or in other unintended consequences.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. STORAGE: Store in cool, dry place. In case of spill, remove spillage with an industrial type vacuum cleaner and wash area with household bleach.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Do not reuse bag. Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

STORED GRAIN DUST M-1 is a special purpose insecticidal dust for use against certain insect pests of edible stored grains and on seeds. This product contains Malathion in a special wheat flour diluent.

STORED GRAINS: CORN (Husked Or Shelled), OATS, WHEAT, RYE, BARLEY - Against such insects as Rice Weevil, Indian Meal Moth, Confused Flour Beetle, Granary Weevil, Saw-Toothed Grain Beetle, Flat Grain Beetle, and Red Flour Beetle, use at the rate of 60 pounds per 1000 bushels (6 pounds per 100 bushels). Mix thoroughly and evenly as the grain is being loaded or turned into storage.

INDIAN MEAL MOTH - To protect stored grain, apply evenly to the surface of clean or uninfested grain at the rate of 30 pounds per 1000 square feet of grain surface area (3 pounds per 100 square feet). Apply evenly, immediately after loading into storage. Repeat if necessary.

NOTE: The surface application should be made after the grain has been treated according to the above mixing instructions for STORED GRAINS.
