The labeling amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, As Amended (FIFRA), is acceptable, provided that you:

Submit one copy of your final printed label incorporating the following corrections before you release the product for shipment.

1. Delete the heading, "INDOOR USE" which appears in the Environmental Hazards section.
2. Relocate the three precautionary statements following the "INDOOR USE" heading from their present location in the Environmental Hazards section to the human precautions section.
3. Revise the statement, "Fyfanon Stored Grain Dust 1% is a special purpose insecticidal dust for use against certain insect pests of edible stored grains and on seeds." to read as stated below.

"Fyfanon Stored Grain Dust 1% is a special purpose insecticidal dust for use against certain insect pests of certain edible stored grains."

4. Correct the water contamination statement to read as cited below.



"Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark."

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish, aquatic invertebrates, and aquatic life stages of amphibians. Do not apply directly to water or wetlands (i.e. swamps, bogs, marshes, and potholes). Drift and runoff may be hazardous to aquatic organisms in areas near the application site. Do not contaminate water when disposing of equipment washwaters. This product is highly toxic to bees exposed to direct treatment on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area. **INDOOR USE:** Use only with adequate ventilation. STORED GRAINS: CORN (husked or shelled), **OATS, WHEAT, RYE BARLEY:**

Against such insects as Rice weevil, Indian meal moth, Confused flour beetle, Granary weevil, Saw-toothed grain beetle, Flat grain beetle, and Red flour beetle, use at the rate of 60 pounds per 1000 bushels (6 pounds per 100 bushels). Mix thoroughly and evenly as the grain is being loaded or turned into storage.

INDIAN MEAL MOTH: To protect stored grain, apply evenly to the surface of clean or uninfested grain at the rate of 30 pounds per 1000 square feet of grain surface area (3 pounds per 100 square feet). Apply evenly, immediately after loading into storage. Repeat if necessary.

NOTE: The surface application should be made after the grain has been treated according to the above mixing instructions for **STORED GRAINS**.
