To control Ants, Armyworms, Billbugs, Chinch Bugs, Clover Mites, Crickets, Cutworms, Earwigs, Grasshoppers, Sod Webworms (Lawn Moths) and Sowbugs (Pillbugs):

Apply CYREN™ 1G insecticide uniformly to home lawns and other ornamental recreational turf grass areas using any hand or power operated gravity or rotary type spreader designed for application of granular materials. Treat when insects first appear using CYREN 1G at the rate of 100 lbs. per acre. To help obtain uniform distribution, apply half the required amount of product in one direction; then apply the rest at a right angle. Immediately after application, water the turf with enough water to wash the granules into the zone of insect infestation. Consult the following table to determine amounts of CYREN 1G and water needed for smaller size areas. Re-treat as necessary.

Fleas, Brown Dog Ticks, Cockroaches (American, Smokey Brown):

<u>Pet Beds:</u> Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet areas. Do not apply this product indoors. To control the source of your *Flea* infestation, treat pets with a product registered for direct application to pets.

<u>In Yard Areas:</u> Apply CYREN 1G uniformly to home lawns, under shrubbery and on other ornamental recreational turf grass areas. Treat when insects first appear using granules at the rate of 1 lb. per 400 sq. ft. or 4 lbs. per 1600 sq. ft. To help obtain uniform distribution, apply half of required amount of granules in one direction, then apply remainder at a right angle. Immediately after application, water the turf with 40 gallons of water per 800 sq. ft. to wash the granules into the zone of insect infestation. Re-treat as necessary. DO NOT TREAT PETS WITH THIS PRODUCT.

<u>Cockroaches</u> (<u>American</u>, <u>Smokey Brown</u>): To help prevent infestation of buildings by <u>Cockroaches</u>, treat a band 6 to 10 feet wide around and adjacent to the building where pests are active and may find entrance. Treat at a rate of 1 lb. per 400 sq. ft. or 2.5 lbs. per 1000 sq. ft.

Fire Ants (individual fire ant mounds): Apply CYREN 1G at a rate of 2 oz. (4 tablespoons) per active mound. Sprinkle granules gently and evenly over surface of active mound and 2 ft. around the mound. Avoid disturbing ants. For best results, apply when ants are least active: in cool weather, 65-80° F, or in early morning or late evening hours. Treat new mounds as they appear.

<u>Turfgrass weevils</u> (larvae of Hyperodes weevil): Apply 5 lbs. of CYREN 1G per 1000 sq. ft. (twice the rate shown in the chart). Apply the granules uniformly over the area to be treated. For best results, treat when grubs are young and actively feeding near the soil surface. Consult your local Agricultural Extension Service specialist for proper time to treat in your geographic area.

European Cranefly Larvae: Apply CYREN 1G at a rate of 3.5 to 4 lbs. per 1000 sq. fts using any granular application equipment as described above. For increased, effectiveness, follow the granule application with a thorough watering to move the insecticide into the soil: apply the equivalent of 1/2 to 1 inch of water to trust. Corrsult your local Agricultural Extension Service specialist for proper time to treat in your geographic area.

White Grub Control (such as larvae of Japanese Beetle, Black Turfgrass Ataenius, European Chafer, And Southern Masked Chafer): Apply 5 to 10 lbs. of CYREN™ 1G per 1000 sq. ft. (two to four times the rate shown in the chart). When high populations of grubs are present in the area to be treated, a repeat application of 5 lbs. of CYREN 1G per 1000 sq. ft. may be made 7 to 14 days following the first application. Apply the granules uniformly over the treated area. Follow the application with a thorough watering to move the insecticide into the soil. Apply the equivalent of 1/2 to 1 inch of water to the turf. For best results, treat when grubs are young and actively feeding near the soil surface. Consult your local Agricultural Extension Service Specialist for the proper time to treat in your geographic area.

<u>Ticks (Brown Dog, Deer)</u> infesting areas around houses and in yard areas: Tuck pants legs into socks to avoid tick bites. An insect repellent sprayed onto lower legs and socks should give additional protection from bites. Wearing light colored pants and socks will aid in spotting ticks that may attach during treatment.

Treat perimeter of house and yard by spreading evenly under shrubbery, in and around ground cover, and around patios. Treat edges or perimeter of yard area where grass and other cover plants exist and other areas that appear likely to serve as harborage sites for ticks that have removed themselves from their host. Use the same amount recommended for control of these pests on turf, as listed in the Rates to Use chart. Prior to and following treatment, weeds and high grasses should be kept trimmed to reduce tick harborage sites. Rodents can serve as hosts for ticks. Rock piles, wood piles, and other rodent habitats should be removed or reduced. Key months for *Deer Tick* control are April through November in most parts of the country. For specific timing of application in your area, contact your local Agricultural Extension Service specialist.

Outside houses and industrial buildings (band treatment): For control of Ants, Crickets, Earwigs, Brown Dog Ticks, Deer Ticks, Armyworms, Clover Mites, Fleas, and Sowbugs (Pillbugs), apply in a 5 ft. band around the foundation at the rate of 1/4 lbs. per 100 sq. ft. (5' x 20') Distribute granules uniformly.

Flower gardens and shrubbery: To control Ants, Armyworms, Crickets, Cutworms, Earwigs, Fire Ants, Grasshoppers, Sowbugs (Pillbugs) Brown Dog Ticks and Deer Ticks, Apply CYREN 1G evenly over soil within flower beds and under shrubbery. Use the same amount recommended for control of these pests on turf, as listed in the Rates to Use chart.
