Number of nozzies: Use the minimum number of nozzies that provide uniform coverage.

Number of nozzies use the higher flow rate nozzies instead of increased backwards, parallel to the airstream, will produce larger droplets than other orientations. Significant deflection from the horizontal will reduce droplet size and increase drift potential.

Nozzie type: Use a nozzie that is designed for the intended application. With most nozzie types, narrower spray angles produce larger droplets. Consider using low-drift nozzies. Solid stream nozzies oriented straight back produce larger droplets than other nozzie types.

Boom length: For some use patterns, reducing the effective boom length to less than 3/4 of the wingspan or rotor length may further reduce drift without reducing swath width.

Applications: Applications should not be made at a height greater than 10 feet above the top of the largest plants unless a greater height is required for aircraft safety. Making applications at the lowest height that is safe reduces exposure of droplets to evaporation and wind.

Sweth Adjustment
When applications are made with a crosswind, the sweth will be displaced downwind. Therefore, on the up and downwind edges of the field, the applicator must compensate for this displacement by adjusting the path of the aircraft upwind. Sweth adjustment distance should increase with increasing drift potential (higher wind, smaller droplets etc.)

Trift potential is lowest between wind speeds of 2 to 10 mph. However, many factors, including droplet alze and equipment type determine drift potential at any given speed. Temperature Inversions

This cloud can move in unpredictable directions due to light variable winds common during inversions. Temperature inversions are characterized by increasing temperatures with altitude and are common on nights with limited cloud cover and light to no wind. They begin to form as the sun sets and often continue into the morning. Their presence can be indicated by ground fog; however, if fog is not present, inversions can also be identified by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.
