

Crop Rotation: Crops treated with TOPGUARD® Fungicide may be rotated to a labeled crop at any time, or may be rotated to cotton, <u>or</u> sweet corn 180 days after application. Rotation to any other crop not listed on this label is prohibited.

Note to PM, optional Crop Rotation statement in case subset-labels are marketed.

CROP ROTATION: Crops treated with TOPGUARD® Fungicide may be rotated to cotton, soybean, field corn, field corn grown for seed, popcorn, sugar beets, peanuts, pome fruit, stone fruit, or grapes at any time or may be rotated to cotton or sweet corn 180 days after the last application. Rotation to any other crop is prohibited for 365 days after application.

Rainfastness: TOPGUARD fungicide is rainfast 2 hours after application. Disease control will be reduced if rainfall occurs within 2 hours of application.

Compatibility Jar Test: Using a quart jar, add the proportionate amounts of the products to approximately one quarter of water with agitation.
