Compatibility Jar Test: FLUTRIAFOL 250 g/L SC Fungicide is compatible with most products, however not all have been tested. Use the following compatibility test to ensure physical compatibility.

Using a quart jar, add the proportionate amounts of the products to approximately one quart of water with agitation. Add wettable powders and water dispersible granular products first, next liquid flowables, then emulsifiable concentrates, and last liquid soluble products. After thorough mixing, allow this mixture to stand for 5 minutes. If the combination remains mixed or can be readily remixed, it is physically compatible. Once compatibility has been proven, use the same procedure for adding products to the spray tank. When tank mixing, follow more restrictive labeling of any tank mix partner. Do not tank mix with any product that contains a prohibition of tank mixing.

For ground application, use a minimum of 10 gallons of spray solution per acre by ground sprayer. For aerial application, use aircraft spray equipment in a minimum of 10 gallons of spray solution per acre for tree nut crops, and 5 gallons of spray solution per acre for all other crops.

Resistance Management: FLUTRIAFOL 250 g/L SC Fungicide contains the active ingredient flutriafol, which is a Group 3 fungicide based on the mode of action classification system.
