Because the product is not intended to treat pulp/paperboard process water (ie., use as a slimicide), change the sentence, "N-521 Dispersion is recommended for use in paper and paperboard processing and other applications related to paper making such as clay processing and processing of aqueous suspensions and dispersions", to the following, "N-521 Dispersion is recommended for use in applications related to paper making such as clay processing and processing of aqueous slurries, suspensions, and dispersions".


D. Again, to make it clear that the product is for preservation, and not process water treatment, change the phrase "...during processing at use levels of 0.5 to 2.5% by weight" to the following, "...during processing at use levels of 0.5 to 2.5 % by weight of the slurry, suspension or dispersion".

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA Section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

GENERAL DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

N-521® Dispersion is recommended for use in paper and paper board processing and other applications related to paper making such as clay processing and processing of aqueous suspensions and dispersions. N-521® Dispersion is effective in inhibiting the growth of fungi and bacteria which cause microbiological degradation and slime formation in slurries and high viscosity suspensions (starches, adhesives, clay slurries, glues, coating, resin emulsions, etc.) during processing at use levels of .05 to 2.5% by weight. Actual use levels required for the preservation of specific formulations will vary depending upon the ingredients, temperature, storage conditions, and time and should be determined by actual test.

Method of Addition: N-521® Dispersion is intended for use as a preservative. N-521® Dispersion should be added at a point in the processing where there will be sufficient time and agitation for thorough dispersion. This product's active and inert ingredients are approved by the FDA (21 CFR) for indirect food contact applications related only to pulp and paper making operations.

STORAGE AND DISPOSAL

1. PROHIBITIONS: Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Keep away from heat and flame. Do not reuse container.
2. STORAGE: Keep container tightly closed when not in use. Do not store near food or feedstuffs. Can be stored at temperatures as low as minus 50°F.
