The Biopesticides and Pollution Prevention Division (BPPD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product may be used for breeding purposes, agronomic testing, and producing seed cotton on up to a total of 20,000 acres per county and up to a combined United States total of 30,000 acres per year. Planting of this product for the purpose of commercial sales is prohibited.

This plant-incorporated protectant may be combined through conventional breeding with other registered plant-incorporated protectants that are similarly accepted for use in combination, through conventional breeding, with other plant-incorporated protectants to produce cotton varieties with combined pesticidal traits.

The following additional restrictions apply to the use of this product:

- No planting of COT102 Cotton is permitted south of Route 60 (near Tampa) in Florida
- Experimental plots and breeding nurseries of COT102 Cotton are prohibited on the U.S. Virgin Islands
- Test plots or breeding nurseries, regardless of plot size, established in Hawaii must not be planted within

- three miles of *Gossypium tomentosum*
- d. Test plots or breeding nurseries, regardless of plot size, established on the Island of Puerto Rico must not be planted within three miles of feral cotton plants
 - e. Upon approval by EPA, test plots and/or breeding nurseries in Hawaii, the U.S. Virgin Islands, and Puerto Rico may be established without restriction if alternative measures, such as insecticide applications, are shown to effectively mitigate gene flow.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store in a cool dry place inaccessible to children.

Pesticide disposal: Any seed not used must be returned to the seed provider.

Container disposal: Do not reuse bag. Ensure that the bag is completely empty of seeds before destroying.
