MIR604\_×\_TC1507\_×\_5307 Corn may be combined through conventional breeding with other registered plant-incorporated protectants that are similarly approved for use in combination with other registered plant-incorporated protectants to produce inbred corn lines and hybrid corn varieties with combined pesticidal traits.

There are no refuge requirements for planting of MIR604  $\times$  TC1507  $\times$  5307 Corn.
