#### Dear Mr. Kutcel:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following label revision provision(s):

# General Comment(s):

 The newly added/proposed alternate brand name (ABN) "Clinical Care Flea & Tick Shampoo" is not acceptable since it implies heightened performance and is also considered false and misleading to the consumer; therefore, you must delete the listing of the proposed ABN and replace it with the active name for this product to read "Groomers Blend Flea & Tick Shampoo."

### Front Panel section comment(s):

In order to incorporate required additional label changes from pages 104 & 128-129 of the revised RED for permethrin (May 2009), you must revise the statement "USE ONLY ON DOGS AND CATS" that is currently listed on the front panel of the subject product packaging to read "USE ONLY ON DOGS AND PUPPIES (OLDER THAN 12 WEEKS OF AGE). DO NOT USE ON CATS OR KITTENS."

Precautionary Statements, Hazards to Humans & Domestic Animals subsection comment(s):

- 3. In order to incorporate required additional label changes from pages 104 & 128-129 of the revised RED for permethrin (May 2009), you must make the following changes:
  - Revise the 4<sup>th</sup> sentence within this subsection to read "Do not use on puppies less than 12 weeks of age."
  - All cat warning labels must have language placed within a shaded text box within the precautionary statements. The coloring of the box and text will be such to provide a contrasting color to other label text. In addition, each label must include at least one (1) cat slash icon which may be in the shaded box or in other areas on the subject label. The shaded box must contain the following:

DO NOT USE ON CATS OR KITTENS. **May be toxic or potentially fatal if applied to or ingested by cats.** Accidental application to cats and/or grooming a recently treated dog may result in tremors and/or uncoordinated muscle movements. If this occurs, immediate veterinary care should be provided.

Please note that these statements are being required on ALL permethrin pet products, including spot-on products, because permethrin is known to be very toxic to cats.

## Directions for Use section comment(s):

4. In order to incorporate required additional label changes from the REDs for pyrethrins and piperonyl butoxide (updated label table for pyrethrins/piperonyl butoxide combo products) and the revised RED for permethrin (May 2009), you must revise the existing 7<sup>th</sup> sentence within this section to read "Do not use on nursing puppies under 12 weeks of age. DO NOT USE ON CATS OR KITTENS. <u>Do not treat cats or their bedding</u>. <u>This product may be toxic or potentially fatal if applied to or ingested by cats or kittens</u>."

Please note that these statements are being required on ALL permethrin pet products, including spot-on products, because permethrin is known to be very toxic to cats.

A copy of your label stamped "Accepted with Comments" is enclosed for your records. Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.
