It has come to our attention that in a small percentage of applications where air conditioner use is heavier than average our product may need to be replaced sooner than the six months currently indicated on the label.


Heavier use basically referring to conditions with higher heat, humidity and/or hours of operation than normal and/or an A/C unit that is inefficient or in need of repair.

We feel adding this statement will prompt our customers to more closely monitor use under extreme conditions.

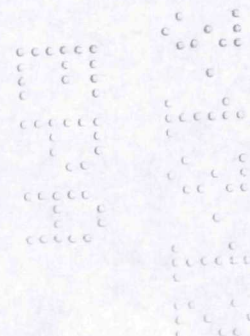
