c. Under "Statement of Practical Treatment" reformat "If swallowed" to all capital letters.

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.
IF ON SKIN: Wash with plenty of soap and water. Get medical attention

Cotton, Dry Bulb Onions, Dry Bulb Shallots, Edible Beans (Dry, Lima, Snap, Chickpeas [Garbanzo beans], Southern Peas [Cowpeas]), Field Corn, Forage Legumes, Garlic, Grain Sorghum, Nonbearing Fruit, Nut Crops and Vineyards, Peanuts, Potatoes, Rice, Soybeans, Sugarcane, Sunflowers, Sweet Corn, Sweet Lupines, and Tobacco
