The labeling, referred to above, submitted in connection with the registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided that you make the following changes:

1. It is recommended that you add a section on "Personal Protective Equipment" with the following statements:

Formulators and handlers must wear:

- Long-sleeved shirt and long pants.
- Chemical resistant gloves made of waterproof materials, such as butyl rubber  $\geq 14$  mils, natural rubber  $\geq 14$  mils, neoprene rubber  $\geq 14$  mils, or nitrile rubber  $\geq 14$  mils.
- Shoes plus socks.


2. Under "Warranty Limitations and Disclaimer";
