Dear Mr. Von Medlin:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, to change the product name and add the statement "MUST BE USED IN CONJUNCTION WITH THE WST IODINE SCAVENGER SYSTEM" is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

Add the "IF SWALLOWED" statement under the "STATEMENT OF PRACTICAL 1. TREATMENT (FIRST AID)" heading.

IF SWALLOWED: If conscious, drink large quantities of water, transport to a hospital and observe for signs of iodine toxicity. If no hospital is available, induce vomiting, drink large quantities of water, and observe for adverse reaction. If unconscious or convulsing, transport to a hospital immediately. Never give anything by mouth to an unconscious person.

2. Add the ENVIRONMENTAL HAZARDS statement:

> This product is toxic to fish. Do not discharge into lakes, streams, ponds or public waters, unless in accordance with an NPDES permit. For guidance, contact the regional office of the Environmental Protection Agency.

3. Add the STORAGE AND DISPOSAL statement:

STORAGE: Store this product in nonmetallic containers resistant to the corrosive action of Iodine, such as glass or polyethylene containers. Keep moist (preferably with deionized water), by storing resin beads with a small layer of water above the settled resin. Keep away from direct sunlight or excessive heat. Do not allow resin to freeze. Do not store in open or unlabeled containers.

The name change from "WST Iodinated Resin Cartridge" to "Iodine Cartridge Release SystemTM" is acceptable.
