Dear Mr. Von Medlin:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, to comply with the Agency's February 17, 2000 letter, will be acceptable provided that you make the labeling changes listed below before you release the product for shipment bearing the amended label.

- 1. The name change from "WST Iodinated Resin Cartridge" to "Iodine Cartridge Release System<sup>TM</sup>" is acceptable **only** for your microbiological water purifier (EPA Registration No. 68158-3). The name of your proposed surface disinfectant must be changed in order to distinguish between the water purifier and surface disinfectant. Two totally different registered products produced by the same company with the same name could be considered misleading.
- 2. Add the following statements under the STORAGE AND DISPOSAL statement:
  - a. Do not contaminate water, food or feed by storage and disposal.
  - b. Securely wrap the cartridge in several layers of newspaper and discard in trash.
