- d. Revise the Statement of Practical Treatment for IF ON SKIN to read: "Wash with plenty of soap and water. Get medical attention if irritation persists.
- e. Delete the statement "Dermal exposure is usually not a concern because disodium octaborate tetrahydrate is not absorbed through the skin."
- f. Revise the Pesticide Storage Statement to read "Store in a cool, dry place inaccessible to children and pets."
- g. Revise the Pesticide Disposal Statement to read: "Securely wrap container and discard in trash."
- h. Delete the statement "Unused product can be distributed around plants in gardens." from the Pesticide Disposal Statement.
- i. In the Directions for Use, delete the phrase "THE BORATE SALT WILL EVENTUALLY LEACH OUT OF THE WOOD UNDER VERY WET CONDITIONS AND".
- j. In the Directions for Use, delete the sentence
 "The borates will eventually leach from the wood
 and the wood will degrade naturally."
- 3. Submit two copies of the revised final printed label for the record.

GENERAL INFORMATION

TERM-A-RID 613 IS A WOOD PRODUCT CONTAINING A 0.5% BORATE SALT KNOWN TO CONTROL SUCH PESTS AS THE POWDER POST BEETLE, OLD HOUSE BORERS, FLAT HEADED BORERS, SUBTERRANEAN TERMITES, DRYWOOD TERMITES, DAMPWOOD TERMITES, CARPENTER ANTS AND DECAY FUNGI. THE TERM-A RID 613 WILL NOT DEGRADE AS RAPIDLY AS WOOD CHIPS,

THE BORATE SALT WILL EVENTUALLY LEACH OUT OF THE WOOD UNDER VERY WET CONDITIONS AND REPEAT APPLICATIONS MUST BE GIVEN YEARLY.

TERM-A-RID 613 IS NOT A REPLACEMENT FOR ROUTINE TERMITE INSPECTIONS AND TREATMENTS WHEN ACTIVITY IS DISCOVERED.. THE TERM-A-RID 613 CAN BE USED BY THE HOMEOWNER IN A MONITORING STRATEGY THAT WILL ASSIST IN DETERMINING WHEN CONTROL ACTIONS MAY BE NECESSARY.

APPLICATION

Apply the wood chips as a mulch along the line of foundation to a distance of three feet from the wooden structure, including garages, tool sheds, pump houses, stables, and homes. Term-A-Rid 613 can also be used around wooden fence posts. The borates will eventually leach from the wood and the wood will degrade naturally.
