# APACIDER - AK

APACIDER-AK is an antimicrobial powder for commercial and industrial use designed to be incorporated into various materials during varying stages of the manufacturing process to preserve the integrity of the manufactured materials. A preservative for use in the manufacture of plastic films, paint (interior), paper coating, adhesive, synthetic fibers and pigments. For more details of the various materials refer to the supplemental labeling for uses of Apacider-AK.

**CAUTION:** May be harmful if swallowed. Avoid contact with skin, eyes, or clothing. Avoid contamination of cooking utensils and food preparation surfaces. Causes eye irritation. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

**STATEMENT OF PRACTICAL TREATMENT:** If swallowed, drink one or two glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit fluid is clear. If on skin, remove contaminated clothing and wash affected area with soap and water. If irritation persists, contact a physician. If in eyes, flush eyes for at least 15 minutes with water. If irritation persists contact a physician.

APACIDER - AK is a silver, calcium phosphate powder designed to be incorporated into various materials at various stages of their manufacturing process to preserve the integrity of the manufactured materials. The powder can be incorporated into the materials as an integral part of the finished products throughout their entire thickness, or as a film over the surfaces of the manufactured materials, depending on the particular method of manufacture of the finished materials and needs of the manufacturer.

APACIDER - AK may be incorporated into the following materials at the specified Maximum Inhibitory Concentrations (MIC) on a dry powder weight basis of finished products.

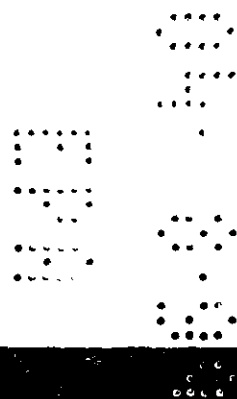

**APACIDER-AK****SUPPLEMENTAL LABELING**

**Claims:** Apacider - AK is to be incorporated into the following materials at suitable stages of the manufacturing process to impart antimicrobial activity to the treated materials, and thus make them suppress the growth of bacteria and mold responsible for unpleasant odors and discoloration of the treated materials.

- FIBERS:** Polyester, Polypropylene, Nylon, Polyethylene, Acrylic, Rayon.  
**Applications:** Mattress cover pads, quilt and pillow fiber fill, curtain and drapery, carpet and carpet underlay, upholstery, wiping cloths, towels, bags, wallcover fabrics, cushion pads, sound proofing, laminate in automobiles, ball point pens and telephones, sheets, blankets.  
 Interlinings, coats, aprons, helmets, gloves, awnings, tents, shades and construction fabrics, industrial & military uniforms sportswear, stockings, socks, caps.  
 Brush bristles, artificial leather, book covers, sail cloth, ropes, shoe linings and filters (non food contact).
- PLASTIC FILMS AND MOLDED PLASTICS:** Polyester, Polyamide, Polypropylene, Polyethylene, Polysiloxane, Polyethylene copolymer, Polyvinyl alcohol, Epoxy resin, Phenol resin, Polycarbonate, Cellulose acetate, Polystyrene, Polyurethane, Acrylic resin, Methyl methacrylate, Acrylonitrile butadiene styrene copolymer, Polyvinyl chloride.  
**Applications:** Gloves, shower curtains, cable wraps, protective covers, non-food contact foam containers, brush handles, sponges, insulators, gaskets, non-food tubing, non-food contact containers and film, furniture, toys, bathroom utensils, kitchen & bath hardware, garden furniture & utensils, slippers, boots, roof liners, and pool liners.
- PAPER COATINGS:** (not for food packaging or for food contact):
