

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Use RESTRICTIONS:

Children and pets should not be in treatment area until after application is completed. Do not treat pets with this product. Avoid contamination of feed and foodstuffs. Avoid contamination of ornamental plants.

PRIOR TO APPLICATION

If carpets need to be cleaned, do so before application. Carpets must be completely dry before application. Before treatment thoroughly vacuum all carpets. Fish tanks and animal cages should be covered during treatments.
