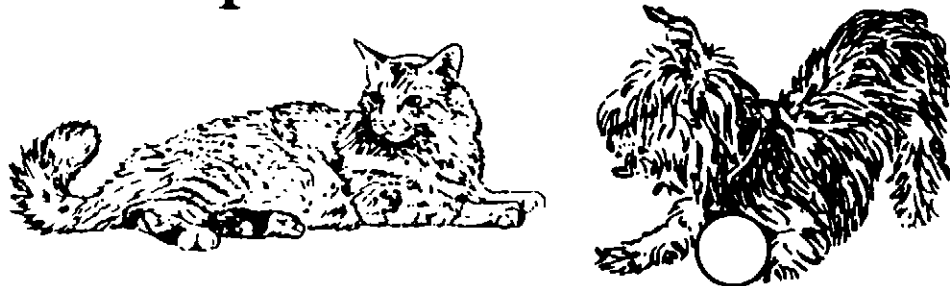

CARPETS: Be sure to vacate entire area of infants, children and pets before application. Apply Flea Master to dry surface only. Apply directly to carpets where pets frequently traffic or sleep at a rate of one pound per 100 square feet (31.5 mg./sq. in.). In other areas you may apply at a rate of one pound per 200 square feet (16 mg./sq. in.). Work powder deeply into fibers with a broom or rug rake. Any powder visible after application **MUST** be brushed into fibers or removed.

ALLOW THREE TO FIVE WEEKS FOR MAXIMUM FLEA CONTROL. REAPPLY AS NECESSARY.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Store in original container, in a dry place inaccessible to children and pets.

CONTAINERS DISPOSAL: Do not reuse empty containers. Securely wrap container in several layers of newspaper and discard in trash.

ONE YEAR MONEY BACK GUARANTEE

Flea Master guarantees if you follow the directions on canister and you still have a flea problem in your home six weeks after treatment, Flea Master will replace this canister of carpet powder, or refund the purchase price.
