Dear Mr. Orman:

The above referenced labeling, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the following comments:

• Upon further reconsideration of your request to add claims to the subject product's labeling, (1) you may retain the claim "Dry spray leaves no mess", and (2) you must delete the word "Residue" from the claim "No Messy Residue", and revise the statement to read "No Mess".

This labeling amendment was accepted with the understanding that it is consistent with the Agency's last stamped accepted labeling dated November 28, 2008, and that the only revision made to the label is the addition of the claim "Dry spray leaves no mess".

INSERT EXTENSION TUBE INTO SPRAY BUTTON:
TO KILL COCKROACHES, ANTS, CRICKETS, SOWBUGS,
CENTIPEDES, SILVERFISH, FIREBRATS AND SPIDERS: Contact
as many insects as possible with the spray. Spray into hiding places such
as cracks & crevices, behind sinks, cabinets, along baseboards and floors,
and hidden surfaces around sinks and storage areas, behind baseboards,
around doors and windows, behind and under refrigerators, cabinets, sinks
and stove and in attics and crawl spaces. For ants, spray around ant trails,
doors and-windows, and other places where ants enter premises. Retreat
every 4 weeks.

TO KILL FLYING INSECTS (mosquitoes, houseflies and gnats): Close space to be treated. Spray above head with a sweeping arm motion 3

feet from surfaces. Spray 10 seconds per 1000 cubic feet of space. Keep treated areas closed for at least 30 minutes after spraying. Ventilate area thoroughly before re-entry.

TO KILL FLEAS AND BROWN DOG TICKS: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames and local areas of floors.

DO NOT SPRAY ANIMALS. Old bedding should be removed and replaced with fresh clean bedding after treatment. Also treat dogs and cats with a registered flea and tick control product before allowing them to enter the treated area.

USE RESTRICTIONS: Flammable. Turn off ALL ignition sources such as pilot lights, other open flames or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.) in and around the area being treated.
