MOTELS AND KENNELS SHAKE WELL BEFORE USE

Do not use in commercial food processing or preparation areas. In the home, all food processing surfaces and utensits should be covered during treatment or thoroughly washed before use. Cover exposed food.

TO KILL COCKROACHES, ANTS, CRICKETS, SOWBUGS.

CENTIPEDES, SILVERFISH, FIREBRATS AND SPIDERS: Contact as many insects as possible with the spray. Spray along baseboards in the kitchens and baths, Also thoroughly spray all parts of the rooms suspected of harboring these pests. Special attention should be paid to cracks, crevices, hidden voids under sinks, cabinets and refingerators and to entry points such as risors, windows, vents, pipes, etc.

TO KILL FLYING INSECTS (mosquitoes, housefiles and gnats)
Close space to be treated. Spray above head with a sweeping arm.

TO KILL FLEAS AND BROWN DOG TICKS: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, walt cracks and local areas of floors. Repeat as necessary, DO NOT SPRAY ANIMALS, Old bedding should be removed and replaced with clean, fresh bedding after treatment. Also treat dogs and cats with a flea and tick control product registered for use on pets before allowing them to enter reated area. STORAGE & DISPOSAL

Store in a cool area away from heat or open flame. Do not contaminate water, food or feed by storage & disposal. Securely wrap original: container in several layers of newspaper and discard in trash.
