Bengal Roach & Flea Fogger  
EPA Registration No. 68543-9

Your Applications Dated February 12, 1996

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

1. We have completed our review of your rebuttal to the dermal irritation study and found it acceptable. The study was classified as Toxicity Category III and based on the acute profile of the product, make the following label changes to the precautionary statements and statement of practical treatments:
  - a. Revise the Hazards to Humans and Domestic Animals to read as follows:

Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Wash thoroughly with soap and water after handling....etc.
  - b. Revise the IF ON SKIN statement to read:

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.
2. For EPA Reg. No. 68543-10, we have no objection to you retaining the site garages on the label.

Bengal Yard and Patio Outdoor Fogger is an outdoor product for use in backyards, patios, barns, stables and other areas where flying insects are a problem. When sprayed on surfaces outdoors, Bengal Yard and Patio Outdoor Fogger residually kills flying insects that land on treated surfaces for 24 hours. **GUARANTEE** - If you are not completely satisfied with this Bengal product, call 504-753-1313 weekdays, 8:30 am - 4:00 pm central time.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. For use around households, yards, patios, pools, and garages.

#### OUTDOOR PESTS:

**FLYING INSECTS:** To Kill flies, mosquitoes, sand flies, no-see-ums, gnats, small flying moths:

**Space Treatment:** Direct fog so that it drifts over the area to be treated. Spray towards bushes, trees and ornamentals from at least 4 to 6 feet away. Give special attention to breeding sites such as garbage cans and compost piles. Do not allow drift over ornamental fish pond pools. Cover if possible before treatment. For spaces such as screened-in porches, spray at the rate of 10 grams (3 seconds) per 1000 cubic feet of space. If possible, keep area closed for at least 30 minutes after spraying. Do not remain in treated area and ventilate, before re-entry.

**Surface Treatment:** For residual control of flying insects, treat screens, around window and door frames, porches, surfaces around light fixtures, ornamental bushes, in garages and other surfaces where flying insects light or gather. Hold can 2 to 3 feet from surface to be treated and spray to slightly moisten the surface. Bengal Yard & Patio Outdoor Fogger will not damage plants and bushes or finished surfaces on homes or buildings. Repeat as necessary.

**CRAWLING INSECTS:** To kill cockroaches, ants, spiders, crickets, sowbugs, centipedes: Contact as many insects as possible with the spray. For residual control of crawling insects on outdoor surfaces, spray where pests are active or where they may enter buildings. Special attention should be paid to cracks and crevices, window and door frames, eaves, porches, patios and garages. Hold can 2 to 3 feet away from surface to be treated and spray to slightly moisten surface. **SPIDERS:** Treat surfaces where spider webs are seen to kill spiders and prevent other spiders from building webs for up to 30 days. Direct exposure to rainfall reduces this products effectiveness. Repeat as necessary.

#### PRECAUTIONARY STATEMENTS

##### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**CAUTION:** Avoid contact with eyes, skin or clothing. Causes moderate eye irritation. Wash thoroughly with soap and water after handling. Avoid contamination of cooking utensils and food preparation surfaces. Do not use on edible crops.

##### PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not use this product in or on electrical equipment due to the possibility of shock hazard. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

##### STATEMENT OF PRACTICAL TREATMENT

**If on skin:** Wash with plenty of soap and water. Get medical attention.  
**If swallowed:** Call a physician or Poison Control Center. Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol.  
**If in eyes:** Flush eyes with plenty of water. Call a physician if irritation persists.

##### ENVIRONMENTAL HAZARD

This product is toxic to fish and other aquatic invertebrates. Do not contaminate any body of water. Do not contaminate water when disposing of equipment washwaters.
