The Agency has reviewed your application for a alternate confidential statement of formula (CSF) for the above noted products. Because the alternate CSFs are essentially the same for both products, both submissions are being addressed in this letter. The alternative CSFs for the above noted products, dated August 3, 2001, are acceptable and will be placed in the appropriate jacket.

You had also asked for a stamped copy of the label to be returned to you. Regarding the label review:

1. Remove "Retreat as necessary". The retreatment statements should include a maximum frequency of application, such as: "... but not more than ___ times per ___."
2. Per the Agency dated 12/11/00, either cite or submit efficacy data to support the public health pests you have on your label. If you can do neither of these, those pest must be removed from your label.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. For use in Households, Schools, Warehouses, Office Buildings, Theaters, Garages, Hotels, Motels, Buses and Kennels.

- In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before reuse. Exposed food should be covered or removed.
- Do not use in commercial food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed.
- Do not apply this pesticide when classrooms are in use.
- Flammable. Extinguish pilot lights before spraying around gas appliances.

INSERT EXTENSION TUBE INTO SPRAY BUTTON:

TO KILL COCKROACHES, ANTS AND CRICKETS: Spray into hiding places such as cracks & crevices, behind sinks, cabinets, along baseboards and floors, and hidden surfaces around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stove and in attics and crawl spaces. For ants, spray around ant trails, doors and windows, and other places where ants enter premises.

TO KILL FLYING INSECTS (mosquitoes, houseflies, gnats, wasps and bees): Close space to be treated. Spray above head with a sweeping arm motion 3 feet from surfaces. Spray 5 seconds per 1000 cubic feet of space. Vacate area. Keep treated areas closed for at least 30 minutes after spraying. Ventilate area before re-entry. Repeat as necessary.

TO KILL SOWBUGS, CENTIPEDES, SILVERFISH, FIREBRATS AND SPIDERS: Contact as many insects as possible with the spray. Also thoroughly spray all parts of the rooms suspected of harboring these pests. Special attention should be paid to cracks and crevices, hidden surfaces, under sinks and behind refrigerators. Treat surfaces where spider webs are seen to kill spiders and keep spiders from building webs for up to 30 days.

TO KILL FLEAS, BROWN DOG TICKS AND DEER TICKS:

Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters, bed, entire floor and floor covering, with special attention to cracks and crevices around baseboards, and window and door frames.

DO NOT SPRAY ANIMALS OR PET FOOD. Do not allow pets to lie, sleep or remain in treated areas during or immediately following treatment and do not allow access until after treated area is dry. Do not use around kittens less than 12 weeks of age.

PRECAUTIONARY STATEMENTS

Hazard to Humans and Domestic Animals

Harmful if swallowed or absorbed through skin. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

Physical or Chemical Hazards
