Dear Mr. Orman:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following label revision provision(s):

Efficacy Review comment(s):

- 1. Within the 1st optional marketing claim, delete the listing of Asian cockroaches since no efficacy (product performance) data has been submitted to support this claim. Product-specific data should be generated with this species; however, data with American cockroach can be bridged to support Asian cockroaches.
- 2. Revise the 2nd optional marketing claim to read "Keeps working on cockroaches for up to 120 days [16 weeks] [4 months]"
- 3. Revise the 3rd optional marketing claim to read "Inhibits [controls] reinfestation of cockroaches for up to 120 days [16 weeks] [4 months]"
- 4. Revise the 6th optional marketing claim to read "One treatment stops cockroaches from generating reproductive offspring for up to 120 days [16 weeks] [4 months]"

Precautionary Statements, First Aid Statements, HOT LINE NUMBER subsection comment(s), page 2 of 2:

5. In order to facilitate inclusion of a missing comment that was included within the SAL for this product, dated March 8, 2011, insert the following text immediately following the "HOT LINE NUMBER" subsection: "NOTE TO PHYSICIAN: Contains petroleum distillate. Vomiting may cause aspiration pneumonia."

USE RESTRICTIONS

- Apply this product only as specified on this label.
- Do not contaminate food or feedstuffs.
- For indoor use only.
- Do not use this product in commercial food/feed handling establishments, restaurants, or other areas where food/feed is commercially prepared or processed.
- Do not use this product while classrooms are in use.
- Do not allow adults, children or pets to enter the treated area for at least 30 minutes following application. Thoroughly ventilate treated areas before reoccupying.
- In the home, cover or remove all food processing surfaces and utensils, or thoroughly wash before reuse. Exposed food and drinking should be covered or removed.

crevices, behind sinks, cabinets, along baseboards and floors, and hidden surfaces around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stove and in attics and crawl spaces. For ants, spray around ant trails, doors and windows, and other places where ants enter premises.

TO KILL FLYING INSECTS (mosquitoes, houseflies and gnats): Close space to be treated. Spray above head with a sweeping arm motion 3 feet from surfaces. Spray 5 seconds per 1000 cubic feet of space. Vacate area. Keep treated areas closed for at least 30 minutes after spraying. Ventilate area thoroughly before re-entry.

TO KILL SOWBUGS, CENTIPEDES, SILVERFISH, FIREBRATS AND

SPIDERS: Contact as many insects as possible with the spray. Also thoroughly spray all parts of the rooms suspected of harboring these pests. Special attention should be paid to cracks and crevices, hidden surfaces, under sinks and behind refrigerators.

TO KILL FLEAS AND BROWN DOG TICKS: Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters, bed, entire floor and floor covering, with special attention to cracks and crevices around baseboards, and window and door frames.

DO NOT SPRAY ANIMALS. Also treat dogs and cats with a flea and tick control product registered for use on pets before allowing them to enter the treated area.
