Add an If Inhaled Statement to the First Aid Statements as follows:

The alternate brand name Concentrated roach and flea fogger II is not acceptable as roaches and fleas must be deleted from the list of pests.

Revise the Storage and Disposal Statements in accordance with PR Notice 2001-6 as follows:

Do not puncture or incinerate!

If Empty: Place in trash or offer for recycling if available.

If Partly Filled: Call your local solid waste agency or [toll free number which fits the criteria of PR Notice 2001-6] for disposal instructions.

Delete the following sites from the label, as you have not provided directions for use: Box cars, boats, closed barns, horse stables, trucks, tents, campers, recreational vehicles, home greenhouses.

Delete the following language from the label as the directions for use as a fogger do not provide directions on how to prevent contamination of food areas: "May be used in inedible (non-food) areas of commercial food processing or preparation areas." Delete also the examples of non-food areas.

Revise the directions for use in home as follows:

In the home, all food processing surfaces and utensils must be covered during treatment or thoroughly washed before use. Cover or remove exposed food.

Delete the food graphic.

Add to the directions for use:

In hospitals, remove patients before treating room. Thoroughly ventilate rooms for two hours before returning patients.

Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

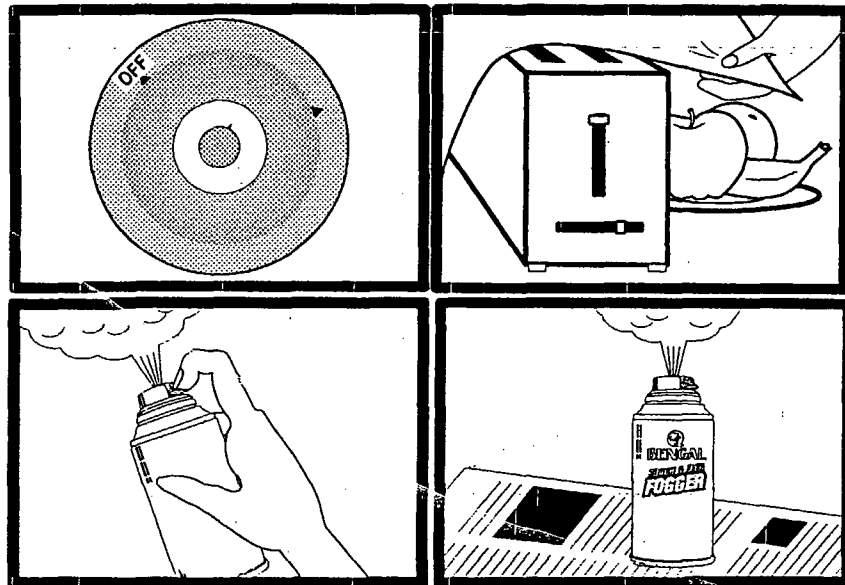

Leave undisturbed for 2 hours. Open doors and windows and allow to air for 1 hour.
