Dear Mr. Orman:

The above referenced amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) section 3(c)(7)(a), is acceptable subject to the following comments and/or terms for conditional registration:

- Remove all claims for, and references to cockroaches from label. A 24 hour mortality of less than 90% is not acceptable to support a "kills' claim for German cockroaches. Also only German cockroaches were used in the study, thus, the data would not have supported "a general cockroach or roach/palmetto bug claim".
- See our review (dated June 15, 2009) of your submitted Efficacy data (Enclosed and previously sent to you on 07/09/09), and revise the labeling to reflect the several comments itemized in the DER.
- The "Kills" claims for fleas are acceptable.

Please note that we have approved the amendment for the subject product with the understanding that (1) this amended labeling is consistent with the Agency's previously approved labels and (2) you have made, or will make all revisions to the labeling as requested in the Agency's letter and NOR dated 09/05/08 and 09/14/07, respectively.

Your failure to comply with the above stated conditions nullifies our conditional acceptance of the proposed labeling amendment. Revise labeling accordingly and submit final printed label to the Agency prior to releasing this product for shipment. See enclosed copies of (1) our "Product Performance/Efficacy Review", (2) Agency's letter and NOR dated 09/05/08 and 09/14/07, respectively, along with the associated previously approved stamped labels and (3) stamped label for your record. 

Example: 20' long x 15' wide x 10' high = 3,000 cu. ft.

PREPARATION: Turn off ALL ignition sources such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance with your pilot lights. All food processing surfaces should be covered immediately prior to treatment or thoroughly cleaned after treatment. Close exterior doors and windows. Open cabinets and interior doors within the treatment area. DO NOT use more than one fogger per room. DO NOT use in small enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft. X 5 ft. or smaller; instead, allow fog to enter from other rooms. Turn off ventilation systems.

TO START FOGGING: Fogger should be placed on the floor in the middle of the room. Place newspapers under the can to prevent marring surfaces. To start fogging press down actuator tab to locked position. Keep it at arm's length when activating. Point top of can away from face and eyes. Set in upright position and leave the building at once. Leave undisturbed for 4 hours. Open doors and windows and allow to air for 15 minutes.


