2. Make the following change(s) to the label:
  - a. Change the product registration number to "EPA Reg. No. 68543-37"
  - b. Make the following label revision(s):

General Comment(s):

1. Delete all text throughout the proposed label marked with "strike-through."
2. Within the product name, replace the word "PYRETHRIN" with the word "PYRETHRINS," so that it reads "BENGAL PYRETHRINS ROACH SPRAY."
3. Claims against public health pests must be removed from the product label. Specifically, since this application was submitted after the pyrethrins DCI was issued; the cite-all method of data support cannot be used for public health pests. In order to support these claims, specific efficacy (product performance) data must be submitted or cited.

Optional Marketing Claims comment(s):

4. Delete the 3<sup>rd</sup> optional marketing claim, since this is an implied safety claim.
5. Delete the 5<sup>th</sup> and 6<sup>th</sup> optional marketing claims, since these claims are not supported by any product performance (flushing) data.
6. Delete the 9<sup>th</sup> optional marketing claim, since it is similar to the revised 8<sup>th</sup> optional marketing claim.

Directions for Use section comment(s):

7. Within the 4<sup>th</sup> bulleted statement of the "USE RESTRICTIONS AND PRECAUTIONS" subsection, insert the word "directly" immediately preceding the word "on."
8. Delete the subsection that starts with "FOR USE IN THE FOLLOWING RESIDENTIAL AREAS (HOMES, DOG HOUSES, ANIMAL QUARTERS, ..." as discussed in detail in item #3 above.
9. Within the subsection heading that starts with "[FOR USE IN HOME GREENHOUSES TO KILLS EXPOSED...", replace the word "KILLS" with the word "KILL."
