The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following label revision provision(s):

General Comment(s):

1. Delete all text throughout the proposed label marked with "strike-through."

Product Brand Name Panel section comment(s), page 1 of 3:

- 2. Revise the main product name which currently reads "BENGAL PYRETHRIN ROACH SPRAY" to read "BENGAL PYRETHRINS ROACH SPRAY"
- 3. The newly added/proposed ABN listed as "Bengal Pyrethrum Roach Spray" cannot be approved. Pyrethrum is the extract that is derived from the chrysanthemum flower, which is formulated into the active ingredient pyrethrins. The subject product contains pyrethrins, not pyrethrum, as its active ingredient.

Optional Marketing Claims section comment(s), page 1 of 3:

4. To incorporate missing comments contained in the NOR (dated 08-31-10) for this product, delete "ANTS, ROACHES, and SPIDERS" from the 1st optional marketing claim.

Directions for Use section comment(s), page 1 of 3:

- 5. Revise the subsection heading "USE RESTRICTIONS AND PRECAUTIONS" to read "USE RESTRICTIONS."
- 6. Within the 4th bulleted statement, insert the word "directly" immediately preceding the word "on."

Directions for Use section comment(s), page 2 of 3:

7. Within the subsection heading that starts with **"[FOR USE IN HOME GREENHOUSES TO KILLS EXPOSED**...," replace the word **"KILLS**" with the word **"KILL**."
