

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive

Causes severe eye damage and skin irritation. Do not get in eyes, on skin, or clothing. Harmful if swallowed or inhaled. Avoid breathing dust. Wear protective eyewear (goggles, face shield or safety glasses). Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse. Also for formulation into end-use products for control of horticultural diseases on turf and ornamentals in and around residences, commercial buildings, nurseries, and greenhouses.

This product may be used for formulating products for any additional uses not listed on the label if the formulator, user group, or grower has complied with U.S. EPA data submission requirements regarding the support of such uses.

FIRST AID	
If in eyes	- Hold eye open and rinse slowly for 15-20 minutes. - Remove contact lenses, if present, after the first five minutes, then continue rinsing eye. - Call a poison control center or doctor for treatment advice.
If inhaled	- Move person to fresh air. - If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth. - Call a poison control center or doctor for treatment advice.
If on skin or clothing	- Take off contaminated clothing. - Rinse skin immediately with plenty of water for 15-20 minutes. - Call a poison control center or doctor for treatment advice.
If swallowed	- Call a poison control center or doctor immediately for treatment advice. - Have a person drink plenty of water if able to swallow. - Do not induce vomiting unless told to do so by a poison control center or doctor. - Do not give anything by mouth to an unconscious person.

Store in original, closed container in a dry location away from heat and out of direct sunlight. Keep away from combustible material. Do not return unused product to container.

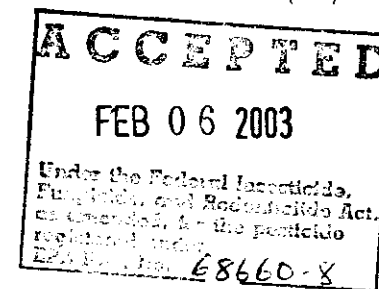
