## PRECAUTIONARY STATEMENTS CAUTION

### HAZARDS TO HUMANS & DOMESTIC ANIMALS

**HUMANS AND ANIMALS:** Harmful if swallowed. Contains petroleum distillate. Do not induce vomiting because of aspiration hazard. Avoid contact with skin and eyes. **IF IN EYES OR ON SKIN:** Flush affected areas with plenty of water. Contact a physician if irritation persists.

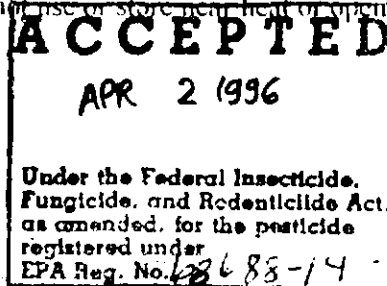
**IF INHALED:** Remove affected person to fresh air. Apply artificial respiration if indicated.

This product is toxic to fish and other aquatic organisms. Do not apply directly to any body of water. Do not contaminate water when disposing of equipment washwaters.

### PHYSICAL HAZARDS

Do not use or store near heat or open flame.



## DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**To Kill Fleas, Lice and Ticks:** Dilute 2 ounces of concentrate with 1 gallon of warm water. Dip, sponge or swab animal with diluted solution, making sure hair is thoroughly wet to the skin. Area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth. Allow pet to dry in a warm place without rinsing or toweling. Dipping should not exceed 30 seconds. This product should not be used on animals more than once every seven days.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Store in a cool area away from heat or open flame.

**Pesticide Storage and Spill Procedures:** Store upright at room temperature. Avoid exposure to extreme temperatures. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, fuller's earth, etc. Dispose of with chemical waste.

**Pesticide Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**Container Disposal:** Triple rinse (or equivalent) then offer for recycling or reconditioning, or puncture and dispose of in sanitary landfill, or by other approved state and local procedures.

**Containers One Gallon and Smaller:** Do not reuse container. Wrap and discard in trash.
