- 1. Revise front of the label-- replace " Inert Ingredients" with the phrase "Other Ingredients".
- 2. Under Precautionary Statements move the statements beginning "Do not use on puppies" and kittens xxx and ending "If signs continue xxx", to the Directions for Use section of the label.

HAZARDS TO HUMANS & DOMESTIC ANIMALS

If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

FIRST AID

To Kill Fleas, Lice and Ticks: Dilute 2 ounces of concentrate with 1 gallon of warm water. Dip, sponge or swab animal with diluted solution, making sure hair is thoroughly wet to the skin. Area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth.

Allow pet to dry in a warm place without rinsing or toweling. Dipping should not exceed 30 seconds. This product should not be used on animals more than once every seven days. Do not use on puppies or kittens under 12 weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. STORAGE: Store in a cool area away from heat or open flame.

DISPOSAL: If empty: Do not reuse this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
