The labeling referred to above, submitted in connection with the registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, revising the label in compliance with PR Notice 2001-1 and 2001-6, is acceptable, provided you make the following changes:

- 1) Under the Hazards to Humans and Domestic Animals, delete the statements:

"In case of contact, immediately flush eyes with plenty of water. Obtain medical attention. If swallowed, do not induce vomiting. This statement is addressed in the First Aid Statement.
- 2) Under the Storage and Disposal section add: "Do not contaminate water, food or feed by storage or disposal.
- 3) A stamped copy of the label is enclosed for your records. Submit three (3) revised final printed labeling prior to releasing product for shipment.

IF ON SKIN OR CLOTHING:	<ul style="list-style-type: none"> Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this

As a precaution, a bland ophthalmic ointment
should be placed in the eyes prior to bathing to
prevent possible irritation.
Thoroughly wet the entire hair-coat with warm

water and then apply enough shampoo to make a lather and work thoroughly into hair-coat. For best therapeutic effects, allow lather to remain in contact with skin for five minutes before rinsing. Rinse thoroughly. Repeat semiweekly or weekly, depending on severity of affliction and response. Do not use on pets less than twelve weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals, or animals on medication.

STORAGE AND DISPOSAL

STORAGE: Store at room temperature. Container not for household use.
