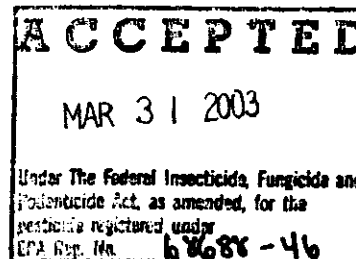

SHAKE WELL BEFORE USING HOLD CONTAINER UPRIGHT

TO KILL LICE AND MITES ON BIRDS: For light infestation of lice or mites, mist birds twice a week until lightly moist, especially at tip of tail. Cover cage with cloth until bird is dry. For severe mite infestation, remove bird from cage and spray perches thoroughly. Clean cages thoroughly at regular intervals.

Keep birds out of cold drafty areas. Do not spray sick birds or birds with open lesions. Avoid spraying in eyes and nares.

STORAGE AND DISPOSAL

STORAGE: Store in a cool area away from heat or open flame.

DISPOSAL: **If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
